Landlord Withdrawal Fees (during tenancy)

For all costs associated with advising the tenant of charges, transferring the security deposit to the landlord or new agent and returning all relevant documents held by the agent to the landlord.

£100 per tenancy



Tenancy Dispute Fee

The costs associated with the preparation of all evidence and submitting the case to the tenancy deposit scheme as well as dealing with all correspondence relating to the dispute. This only applies where the agent has protected the deposit.

Court Attendance Fees

£50 per hour



Vacant & Additional Property Management Visits

Visits when either vacant, or additional when occupied, for visiting the property to undertake visual checks on the inside and outside as agreed with landlord.

Management Take-over Fees

For costs associated with taking over the management of an ongoing tenancy, ensuring all statutory compliance has been undertaken, receiving and protecting the security deposit and providing all necessary legal documentation to the tenant.

Interest on Unpaid Commission

3% above the Bank of England Base Rate from due date until paid



Additional HMRC Reporting Fees

Responding to any queries relating to either any return or information required about the landlord, property and/or tenancy from HMRC.

CONTRACTOR COMMISSION & MAINTENANCE ADMINISTRATION

We arrange, coordinate, and oversee safety certifications and property maintenance on your behalf. Because independent third-party contractors charge varying base rates, the final cost to the landlord will consist of the Contractor's Invoice Cost plus our fixed Agent Administration Fee. This fixed fee is paid directly to us as the agent to cover sourcing, scheduling, vetting, and managing the works. We are not VAT registered, so no VAT applies to our fees.
